· Product category

JUBOLIN F is two-component thin balancing weight (component A : mineral powder mixture , Component B : Acrylic emulsion - AKRIL EMULZIJA). Application on smoothing solid - with cement bound façade surfaces (lime and cement plasters , unplastered concrete surfaces) .

· Application of the substance / the mixture

JUBOLIN F is suitable for repairing minor - surface defects and damage such as dents, cracks , holes , scratches , cuts , and the like repair and fine facade decorations whereby it is usually reinforced with special thin fabrics of synthetic fibers . It can be used for smoothing concrete surfaces unplastered as well as lime and cement plaster inside buildings , if such areas are provided for decorative processing require sharp high strength substrate.

JUBOLIN F is a good enough grasp of each solid mineral surfaces , distinguished by good water repellence and high strength properties . Polished surfaces can be overcoated with all types of facade and other water borne wall paints, including paints produced on the basis of organic solvents .
