It adheres well to all fine-coarse construction surfaces including: base-coats of ETICS systems, classic fine lime-cement and cement renders, smoothed concrete surfaces and also to fibre-cement and gypsum-cardboards, chipboards and similar.

· Application of the substance / the mixture

Specially selected unique shades are typical of **KULIRPLAST 18 PREMIUM** acrylic renders. In combination with the shades of **JUBIZOL** facades, they ensure solutions of modern architectural trends. Innovative technology of paint application with specially selected pigments and the use of the state-of-the-art binder with high UV protection ensures excellent resistance to atmospheric loads and high water repellency of the product. **Kulirplast 1.8 premium** has excellent applicative characteristics and is easy to apply. Acrylic renders are also distinguished by atypical relatively high values of water-vapour permeability due to which they may also be applied as render finishes or decorative renders in ETICS systems.

Acrylic renders are relatively easy to apply. Surfaces processed with acrylic renders are provided with long-term resistance to contamination with wall algae and mould. Therefore, it is not necessary to add any biocidal substances prior to application.
